**PER THE NAAR BYLAWS:**

Effective January 1, 2017, each REALTOR® (primary) member of the association shall be required to complete Code of Ethics Training of not less than two hours and thirty minutes of instructional time every two years. This requirement will be satisfied upon presentation of documentation that the member has completed a course of instruction conducted by this or another association, the State Association of REALTORS®, the National Association of REALTORS®, or any other recognized educational institution or provider which meets the learning objectives and minimum criteria established by the National Association of REALTORS® from time to time.
